The Mid-Michigan Chapter of the Chartered Property Casualty Underwriters Society (CPCU), an organization for insurance professionals, offers scholarships for college students attaining their junior or senior status during the 2020-2021 academic year and have a demonstrated interest in entering the insurance field.

Two scholarships will be awarded by the Society this year. Each student will be awarded a \$1,000 scholarship. The scholarships will be for the 2020 – 2021 academic year.

The scholarship application requirements are as follows:

- Cumulative grade of 2.5 or higher
- Insurance related major of study or related interest (i.e. Actuarial Science, Business, Information Technology)
  - If major is other than insurance related, an internship or employment in the insurance industry is required
- Junior or Senior class standing for 2020 – 2021
- Unofficial transcript through Fall 2019
  - Official transcripts will be required if awarded the scholarship
- Resume and completion of the application
- Short essay on why the candidate should be considered and how the scholarship will be used and benefit the candidate
- One letter of recommendation from a professor, advisor, or employer
- Photo suitable for business publication

Applicants awarded the scholarships will be invited to attend a CPCU Society chapter luncheon meeting in fall 2020.
